These dentists must sign an agreement with ALSLC and provide proof of malpractice insurance. ALSLC also collaborates with the Utah Dental Association and other community dental clinics and programs.
- 7. Operation: ALSLC has established a process for schools, agencies and dental offices to make referrals at any time for necessary, urgent care, including orthodontic treatment. School personnel and dental professionals identify, qualify (to make sure they have no other means of payment for treatment) and refer children, pre-K through 19, to our program. After the child is approved, an appointment is set up with one of the participating dentists. OHT provides a contribution per patient for x-rays, amalgam, anesthesia, composites, chair side assistance, etc., and the dentists typically donates their time.
