

AGREEMENT BETWEEN
Assistance League® of Salt Lake City
and
Dentist Participating in Give Kids A Smile

This agreement is entered into as of this _____ day of _____, 2____ between Assistance League of Salt Lake City, a non-profit corporation, (hereinafter "ALSCLC") and a dentist licensed to practice dentistry in the State of Utah, (hereinafter "Dentist").

RECITALS

ALSCLC operates a charitable program known as Operation Healthy Teeth. One purpose of this Program is to provide financial means for dental care to children identified by selected schools in the area. Utah Dental Association has a committee that conducts a free clinic day named Give Kids A Smile. The parties hereto agree as follows:

A. OBLIGATIONS of Assistance League of Salt Lake City:

1. ALSCLC will attend the Give Kids A Smile Clinic Day and distribute a book relating to dental health or dentistry to each child in attendance.
2. ALSCLC will inform participating dentists attending the clinic day and dentists who have indicated a willingness to see children for follow up care in his/her own practice that ALSCLC will reimburse a dentist for laboratory fees and expenses other than the dentist's own donated time (hereinafter "lab fees") providing that there is no other reimbursement for those expenses.
3. Reimbursements will be paid in a timely manner upon receipt of bills.
4. ALSCLC will limit the reimbursement to \$1000 per child per year as long as funds are available.
5. ALSCLC will inform Dentist when funding for Operation Healthy Teeth has been exhausted.
6. ALSCLC will not act as an intermediary for the Dentist and patient or patient's parent / guardian.

B. OBLIGATIONS of Dentist:

1. Dentist will register with the Give Kids A Smile as a participating dentist on the clinic day or will register to provide vouchers to Give Kids A Smile for follow-up care in his/her own office.
2. Dentist will maintain a satisfactory standing with the Department of Occupational and Professional Licensing and will inform ALSCLC of any change in status.
3. Dentist will bill ALSCLC for lab fees or additional services beyond his/her donated time that are required to complete the dental care for the child identified on the clinic day.
4. Dentist will bill ALSCLC only for lab fees not reimbursed by any other source.
5. Dentist will indemnify and hold ALSCLC and its officers, directors, agents and volunteers harmless from any and all liabilities arising from or relating to Dentist's participation in Give Kids A Smile and Operation Healthy Teeth programs.

C. PUBLIC RELATIONS:

1. Dentist will not release any publicity relating to ALSCLC or Operation Healthy Teeth without prior approval from ALSCLC.

Photos and names of Dentist or patients shall not be used by ALSLC without written permission of those directly involved or the parent/guardian of a participant.

D. RENEWAL and TERMINATION:

It is the intention of ALSLC to continue this program for an indefinite period of time. However, when either party determines it can no longer abide by the terms of this agreement, it may terminate this program by giving written notice. The notice should be received thirty days prior to termination.
